4. The Client has the right to withdraw the amount of deposit before the maturity of the deposit agreement. In this case the Bank performs the recalculation of the interest. The Bank charges from deposit amount already paid interest and pays interest in accordance with the rates which are approved and placed on the Bank's website in the Deposit currency, interest accrued in accordance with the annual interest rate approved by the Bank for the on-demand type of deposit.
5. Interest income is taxable according to the "Law on income tax" of the Republic of Armenia.
6. Other terms and conditions are regulated by a contract or an additional agreement.
7. The client has the right to receive loans secured by pledged deposit according to the terms defined by the Bank. If the client presents the application for receiving loan until 12 o'clock of the banking day, the loan is provided on the same day till the end of the operation day. If the client presents the application for receiving loan after 12 o'clock of the banking day, the loan is provided during the next banking day.
